1. Call to Order

On September 25, 2021 there will be a scrap tire event in Kaleva at the Bay Area Recycling for Charities (BARC).

5. Approval of Minutes from the previous meeting

6. Reports

Supervisor - Paul Adamski reported that he had 2 land use permits #1435 and #1436. He went to the County Commissioners meeting. Two dumpsters were here over the holiday weekend and they were both filled.

Clerk - No clerks report since Deborah Knutson was absent.

Treasurer - Lani Millsap presented financial reports showing check #13886 to #13908 for payments. Total disbursements of \$9,477.91. Tim Joseph made a motion to pay September's bills; Paul Wondolowski seconded. Motion passed. The Treasurer's Report was received showing a current passbook balance of \$318,898.97.

7. New Business

a. Spectrum Broadband Contract - Paul Adamski suggested signing the Spectrum (Charter) Broadband Contract but putting zero percent in franchise fee not included to make residents pay for broadband. Tim Joseph moved to sign the contract; Paul Wondolowski seconded. Motion Passed.
