The subject of this advertised public hearing is to consider the appropriation of money needed to support the proposed budget for the upcoming fiscal year (July 1, 2021 – June 30, 2022).

Anticipated revenues and expenditures for the proposed budget were reviewed. There were salary increases for the Supervisor, Clerk and Treasurer. There was meeting pay increases for Trustees, Planning Commission, Board of Review and Board of Appeals. There was an increase for Election Inspectors, Hall Administrator and a wage was given to Deputies. Fees were also increased for Land use Applications and Land Use Parcel Split Review. Road budget was increased from \$75,000 to \$150,000 because of the work that will be done on Lyman Road for 2021/2022.

After a brief discussion, the following **resolution was offered** by Deborah Knutson with a second by Tim Joseph:

The Brown Township Board hereby resolves to levy under the general Property Tax Act, a total of 1.4603 mills for the operation of the township during fiscal year 2021-2022 (July 1, 2021 – June 30, 2022); and to levy .9779 mills as a regular voted assessment millage designated for fire and rescue services; and further to levy 1.5 mills as a regular voted assessment millage designated for road repair, construction and maintenance.
